EQUESTRIAN AREA

The Equestrian Area includes the existing main field, round yard, square yard, day yards, wash bay parking areas, and stables.

Users are defined as any individuals or groups wishing to use the equestrian area for the purpose of equestrian or equestrian related activities.

GROUND FEES AND MAINTENANCE CONTRIBUTION:

A yearly fee is payable by all users to contribute towards up keep of facility/equipment:

Individual user rate: Defined as individual person who wishes to use the facility over the course of the year, \$30 per year.

Family user rate: Defined as family who wishes to use the facility over the course of the year, \$50 per year

Day User rate: Defined as any person who wishes to use the facility on a single day basis. \$5day

Tuition Rate: Any instructors/clinicians who is using the facility for a fee paying service, are required to pay either \$100/yr or 10% of the fee rate per client/per lesson.

This includes day use of the stables/yards. Overnight use will be subject to a separate stabling charge (see below).

USER RESPONSIBILITIES:

Notification of use: Regular user groups are required to notify the Kununurra Agricultural Society Equestrian Sub-Committee of season dates including special events as they arise.

In the event of two or more user groups wishing to use the equestrian area on the same dates and times, use will be negotiated with the Equestrian Sub-Committee and if shared use cannot be agreed the Equestrian Sub-Committee will make a decision on priority of use.

Adherence to agreement: The user group or organiser of any event is responsible for ensuring all participants are informed of and adhere to the terms of use of the equestrian area as detailed in this user agreement.

Rubbish Removal: Rubbish is to be placed in the bins provided or removed from the grounds at the end of each use. User groups should encourage their members and participants to keep the equestrian area clean and tidy for the benefit of all users.

Insurance: All users must provide the Equestrian Sub-Committee with a certificate of currency for public liability insurance if held. If public liability insurance is not held all individual users and all members of user groups must complete a liability waiver form provided by the Kununurra Agricultural Society. It is the responsibility of user groups to ensure that all their members or participants complete these forms and return them to the Equestrian Sub-Committee. It is the responsibility of user groups and individual users to insure their horses, property and person against all risks whilst they are on the Kununurra Agricultural Society grounds.

Helmets: All persons riding on the Kununurra Agricultural Showgrounds including the equestrian area must wear an Australian Standards Approved riding helmet.

Boots: Appropriate foot is required when riding at the Show grounds. Preferably a proper riding boot with a heel. Riding in sneakers is not encouraged.

Stabling: Stables and yards are available for use. The fee for overnight stays is \$5 per horse per night. There will be no charge for day use provided that stables and yards are kept clean and tidy. For weekly agistment see separate agreement.

Cleaning of stables/yards: Manure must be removed to the muck heap daily. Water troughs are available and users are asked to use water wisely. Troughs are to be left clean and empty when vacating the yards. A \$20 daily cleaning fee will be charged if stables/yards are not left clean.

Collection of stabling fees: Fees from regular and casual users will be collected by the Equestrian Sub-Committee. If a user group organises a special event or competition, the user group will be responsible for collecting any stabling fees due from participants in the event.
